## Forced Pooling Status Update #2

Greetings, Friends-- We are writing today with GREAT news!

On Thursday, Tommy Butler, the Hearing Officer in the Fruitland forced-pooling matter/s, granted Citizens Allied for Integrity and Accountability's (CAIA's) request to officially intervene on behalf of our members threatened with Integration by Alta Mesa's two applications for Sections 14 and 19!

**It is now official: CAIA is the ONLY organization in the State of Idaho with the legal authority to challenge this blatant attempt to force Idaho citizens to give up their property rights.**

The next step is the Discovery process. The re-scheduled hearing date is *Thursday, November 19th at 9:00 a.m. at the Statehouse in Boise*. **Please mark your calendars and plan to attend if at all possible.** We need to send a strong message that we will not sit idly by while our most basic rights are taken from us and handed to industry on a silver platter.

As you can imagine, this legal process is not inexpensive. To date we have spent approximately \$10,000 fighting for YOUR private property rights and property values (and we call it *well-spent*).

We are going to need an additional \$15,000 by the end of the year to see this through the Administrative Hearing process. Should these applications be rubber-stamped by the Idaho Oil & Gas Conservation Commission, we are prepared to appeal - and it should be understood that this initial application by Alta Mesa is merely the opening salvo to make way for many other attempts to force leasing on Idaho residents.
